Susan Litwin thanked the Trustees for their time. She explained that she and Jim Brown are the Co-Chairs of the RDHS-Community Committee. She advised that the Committee was developed because they were included in the eight phases of the proposed Accommodation Reviews. Committee members include parents, community members and a Delaware First Nation representative. She acknowledged that they are not under review yet. They know that the Trustees have not acted on the recommendations or phases yet. They know that enrolment and finance are the two main factors behind the proposed ARC phases; that the LKDSB is interested in replacing schools with a high Facility Condition Index (FCI) and that status quo in South/East Chatham-Kent is not an option. She outlined the four requests of the RDHS-Community Committee. She advised that they would like the LKDSB to proceed with the ARC as soon as possible because RDHS is under a cloud. The uncertainty causes distress for students who think there is no future at RDHS. They are looking at other options rather than RDHS so the numbers at RDHS could go down. She commented that teachers may choose to look for another job as well. She commented that the vitality of the school could be

lost. She referred to the LKDSB Capital Plan and the Pupil Accommodation Report both of which do not account for the fact that the Grade 7 and 8 students are at RDHS. They are concerned that that is a misrepresentation of enrolment in the school. She suggested that the LKDSB convince the government to recognize the elementary students in the building. She encouraged Trustees, before voting to establish an ARC regarding the consolidation of the Ridgetown and Blenheim area schools, to reconsider the current proposal and ensure that the ARC is based on the best proposal possible. They do not believe it is the best. She asked Trustees, when consolidating schools in South/East Chatham-Kent, to not be limited by the framework of the past, solving the puzzle by simply moving whole pieces based on existing catchments. She asked Trustees to consider a re-design for the entire region affected (Tilbury-Chatham-Blenheim-Ridgetown). She presented maps of the proposed consolidation in Blenheim and a proposed consolidation in Ridgetown. She proposed that an alternative re-design option, closing Blenheim District High School and sending South/East Chatham-Kent secondary students to high schools in Tilbury, Chatham and Ridgetown would be more efficient and inclusive, providing all students with at least one high school option within a reasonable distance. This alternative would increase enrolment levels at multiple schools and would not require new school construction. The Board could move all W.J. Baird Public School students into Harwich-Raleigh Public School. LKDSB could seek a Capital Priorities Grant to build a K-12 school in Tilbury (instead of Blenheim) to address Tilbury District High School's very high FCI. She advised that this broad-based alternative considers enrolment, finance and student well-being. High school students at a school in Ridgetown would benefit from the completion of the Ridgetown Community Sports Field, the Board's recent investment of over \$4 million in RDHS, and its close proximity to the University of Guelph-Ridgetown Campus. The older classroom-portion of the RDHS building could eventually be replaced to reduce the school's FCI, and there is adequate room for expansion, if necessary. She commented on the current travel distances and future travel distances under the proposal for students living in Moraviantown. She commented on the relationships made with the students at Naahii Ridge Public School. She explained that the presentation is not intended to provide the complete argument for changing the consolidation proposal for the Blenheim-Ridgetown area schools and invited staff to meet with them to discuss their ideas. A copy of Susan Litwin's presentation is attached to the Minutes.

Questions from the Public

Mary Ethier referred to the questions posed by Keith Wyville during his delegation to Board at the February 9, 2016 Board Meeting in Chatham and asked what was the process for selecting community representatives to serve on the ARC and for selecting students to serve on the ARC.

Superintendent Girardi explained that the task was given to school principals. The selection is usually done by working with the schools councils and student councils. Parent, student and community members are individuals who are involved in the school and active within the school community. This was the approach taken with the four schools involved in the current Accommodation Reviews.

Jim Brown referred to the information provided to the Board by the RDHS-Community Committee and stated that there was more information they needed to consider prior to making any decisions and questioned what would the process be after tonight regarding the information received from the Committee.

Director Costello advised Mr. Brown to provide the additional information to himself and Superintendent Girardi and it would be reviewed by prior to

making a recommendation to Board.

Mr. Brown asked if they would review the information and decide not to include RDHS in an ARC and report back to the Committee prior to an ARC being called. Director Costello advised that this would not happen. Administration has not decided an order for the remaining proposed Accommodation Reviews. The current proposals are visions based on the data that is available now but things could change. Administration would have to present an Initial Staff Report to the Board which would have to be approved by the Board to commence future Accommodation Reviews. Director Costello noted that Susan Litwin's report was well done and that the information would be considered.

She explained that Administration is requesting a modified calendar that would include a change in the Christmas Holiday. The Ministry deadline for submission of modified school calendars is March 1, 2016.

Ontario Public School
Boards' Association
Update
(OPSBA)

Trustee Fletcher reported on the February 19 and 20, 2016 OPSBA Directors' Meeting. He shared the agenda from the meeting with Trustees. Syrian new comers to Canada were discussed. The Ministry of Education has produced a guide for parents/guardians - *Guide to Pupil Accommodation Reviews*. Feedback is being obtained on the School Boards Collective Bargaining Act. Trustee Fletcher found the First Nation Director's report was very interesting. The OPSBA Director's passed a motion to open every OPSBA board meeting with an acknowledgement that the meeting is being held on traditional territory. He commented on sensitivity training for staff and trustees. He encouraged Trustees to read the EQAO assessment information, item 17 2.6 on the OPSBA Agenda he shared.

Accommodation Review
Committee Updates

Superintendent Girardi advised that the first Working ARC Meeting for the Sarnia South Secondary Schools was held at the Sarnia Education Centre on February 16 from 6:00 p.m. to 9:00 p.m. The second public ARC Meeting is scheduled for March 8 at SCITS. Superintendents will be meeting with the staff from SCITS and SCSS this week. Public tours of SCSS took place on February 22. Tours will take place at SCITS on February 24. He reviewed the discussion items from the first Working ARC Meeting. There was good dialogue amongst the members on reflections on the first Public ARC Meeting, secondary program options, examination of suggested alternative proposals (status quo, SCSS and SCITS move to a Grade 7 to 12 model, consolidation at SCITS and turning SCSS into an elementary, closure of additional Sarnia secondary schools for a new consolidated school, LKDSB Initial Staff recommendation to close SCITS and move all the students to SCSS). At the conclusion of the discussions, ARC members chose to continue discussions on consolidation of all the students at either SCITS or SCSS at the next Working ARC Meeting.

Superintendent Girardi reported that the first Wyoming Area Schools Working ARC Meeting is scheduled for February 29, 2016 at Wyoming Public School and the second one will be held on March 31 at Wyoming Public School. Meetings with staff from both schools have been scheduled. The public walking tour for Wyoming Public School will be held on March 9 and the tour for South Plympton Public School will be held on March 10. The second Public Meeting will be held on March 23, 2016. ARC members will reflect on the first Public Meeting, review options (status quo, LCCVI becoming a Grade 7 to 12 school model, consolidating at South Plympton and closing Wyoming and the LKDSB Initial Staff recommendation to consolidate at Wyoming and close South Plympton).

Chair Bryce commented on the question and answer section on the LKDSB website for both Accommodation Reviews and commended staff on the detailed answers provided to the questions. She noted the inclusion of pictures demonstrating various conversions of gymnasiums into classrooms on the Wyoming Area Schools ARC site.

Trustee Question

Trustee Fletcher referred to the tragedy that occurred in Pickering on February 23 involving the stabbing of students by a student. Director Costello commented on the support offered to the students and staff of the Durham District School Board through their Director. On behalf of the LKDSB, he has expressed concern for the students and staff.

Trustee Douglas referred to the proposed funding request for \$14M to consolidate the students from SCSS and SCITS at SCSS and questioned how much it would cost to consolidate all the students at SCITS. He questioned if the Ministry would provide funding and how much longer the LKDSB could utilize SCITS.

Superintendent McKay explained that the Board would have to apply to the Ministry for a similar amount of funding to consolidate students from SCSS and SCITS at SCITS. The main difference in calculating the success of the application is the schools' FCI. In the grant application calculations, the Ministry looks at the FCI and compares it to the Ministry's threshold of 35%. SCSS's FCI is approximately 40% and SCITS's FCI is approximately 60%. SCITS's larger FCI is a consideration on the potential success of the grant application if the students were to be moved to SCITS. During a meeting Superintendent McKay had with Ministry representatives, they looked at both FCI numbers in the grant application process. The grant application scored higher for locating all the students at SCSS. The grant application score for moving all the students into SCITS was favourable but not as favourable a score as moving all the students into SCSS. There is an element of risk for grant applications. Historically, the Ministry receives about four times as many applications as there is funding available for. The consolidation of students at SCITS meets the Ministry's base line matrix but does not score as high as a consolidation at SCSS. The Ministry will not provide school boards with the information on their risk calculations. This is dependent on the number of applications they receive and how the Ministry scores the applications.

Superintendent Girardi commented that they are working on compiling 40 year long-term capital forecasts for both buildings to share with ARC members at the March 21 Working Committee Meeting. The associated financial costs will be shared at the meeting as well. The most recent asbestos reports and associated costs will be shared as well as costs associated with accessibility. The event costs for SCITS are \$52M and event costs SCSS is \$34M.

SUBJECT: Native Advisory Committee Report

The February 17, 2016 meeting of the Native Advisory Committee was hosted by Wallaceburg District Secondary School.

Reports from communities indicated ongoing involvement with the Anishinabek Education Framework process in collaboration with the province. It is expected that finalization of this plan will occur late in the fall of 2016. In addition, the staff of Hillside School at Kettle Point will be joining the North Lambton family of schools for a numeracy workshop at the invitation of the board's program department. The sharing of two-way professional development opportunities is a goal identified by the NAC.

Trustee Rising made mention of a web presentation by noted First Nation speaker Wab Kinew to Ontario public service employees, followed by the Premier's announcement of mandatory training for all provincial employees on FNMI perspectives, revised training for pre-service teachers, and mandatory elements to be included in the Ontario curriculum. The board will request resources available from the Truth and Reconciliation Commission for use in gr. 8 and gr. 10 classrooms.

Aboriginal Liaison Chris Riley reviewed his work with program staff to support teachers implementing the new gr. 11 English course and gr. 9 Arts course which are both based on FNMI history, culture, and perspectives. SCITS will be hosting the annual youth symposium this May and the theme will be "Reviving our Roots." Chris also talked about the growing interest on the part of schools in recognizing protocols relating to First Nations. An example of this would be recognizing traditional territories during morning announcements with appropriate language and respect accorded. A regional treaty council of Chiefs and others will be meeting to establish a template that schools can use to guide their recognition.

School administrators in attendance shared details of FNMI-focused learning that is taking place in their schools including collaborative inquiries, community involvement, follow-up to the Truth and Reconciliation recommendations, and community visits.

Future agenda items include a presentation on protocol, sharing of student achievement data, revisions to the Voluntary Self-Identification policy and regulations, and the annual financial report.

The next meeting of the Native Advisory Committee will be held on Wednesday, April 20, 2016 at the Chatham Regional Education Centre – 6:00 pm.

SUBJECT: SPECIAL EDUCATION ADVISORY COMMITTEE MEETING SUMMARY

The Special Education Advisory Committee (SEAC) of the Lambton Kent District School Board met on February 18, 2016 via Video-Conference. Following is a report of the activities of the meeting:

Presentation: Differentiated Supports for Diverse Needs

Lee-Ann Chamberlain, ALLP Teacher, and Laurie Brownlee, Elementary ESL Teacher, made a joint presentation with regard to the Alternative Learning and Life Skills (ALLP) Class at Tilbury Area.

Lee-Ann advised SEAC that there are a number of English Language Learner (ELL) students at the school. (A student is an English language learner when another language – aside from English or French – is spoken in the home.) She shared a presentation with the members of SEAC that provided a glimpse into a typical day in the ALLP class and spoke about specific tasks they teach in the Life Skills class, noting that content is tailored to each child's unique needs. The classroom is very inclusive and is credited for helping the students thrive.

Laurie Brownlee began collaborating with Lee-Ann a few years ago to support their school's ELL needs. Laurie said that the students really enjoy being in Lee-Ann's classroom. One year they had 23 ELL students. One third of the school's population has English language learning needs. Children are taught in small groups so they're more comfortable and their individual needs can be met.

At the conclusion of the presentation Superintendent Doey said that Tilbury Area Public School received the Premiers' Award for being a Safe and Accepting School last year, and the ALLP was a key part of the school's commitment to supporting the diverse learning and non-academic needs of its students.

Presentation: How Are We Preparing Our Students for the 21st Century?

Mike Adam advised SEAC that the Assistive Technology Team is very busy. He said that a '21st century learner' is one who is agile and can readily adapt to new technologies. Their team is continually sourcing out leading edge technologies so they can put the tools into the hands of the Board's students. The team is responsible to do assessments and introduce new technologies; as a result, they provide coaching to both the students and the teachers. And, since all students have iPads in Grade 7, the team has introduced iPads into the Grade 6 classrooms so that the students will be ready when they get their device the following year.

Students are shown a variety of devices and Apps and are allowed to choose what's best for them. Mike showed a presentation that provided an overview of the various programs/Apps that students are using and explained the ways that they benefit the student's learning while helping the teacher and student connect using vocal annotation, and more.

A member of SEAC asked how the Board is measuring the success of students who are using new technologies. Mike said that the team does a trial first, in order to set specific goals that are based on Report Card comments. At the end of the trial, they are then able to measure the student's progress towards those goals.

Superintendent Doey said that the Assistive Technology Team is supporting the TELP project by going into the classroom to model how lessons can be taught using the new technology, and helping to change instructional practices in the classroom while at the same time helping students access and demonstrate their learning.

Another member of SEAC asked if the Team helps parents to understand the technology so they can help their children at home. Liz Zantingh responded saying that when training is offered to the students, parents are invited to attend as well. As well, the Technology Team sometimes offers technology camps, and parents are welcome to come to those sessions.

Superintendent Doey said that the Board is working to open the world up to the students by making education more inclusive, and by extending differentiated instruction to focus on everyone's unique needs.

The members of SEAC were advised that the Accessibility Plan will be replaced with the Board-approved 2015-2016 version; the Plan will be provided to SEAC for its information and use when it's available. As well, Pam Graham, System Coordinator of Special Education reviewed the amendments that have been made in Sections 2.5, 2.8 and 2.9, and provided an explanation as to how and why the sections were changed.

Correspondence

There was no correspondence submitted to SEAC.

Associated Reports, Other Business and Sharing of Best Practices

Trustee Hudie said that the Board is very busy with the Accommodation Review process.

Christy Bressette, First Nations Representative, reported that there will be a National First Nations' Directors Forum in Ottawa next week and noted that it will be the first time that such a meeting has taken place in Canada.

George Melendy noted that the Learning Disabilities Association of Lambton County received funding from the United Way of Sarnia-Lambton to continue the delivery of their programs.

Gordon Crompton of Community Living - Chatham-Kent shared details about a program he heard about. "Open Minds" is being launched by ACCESS (Adolescent/Young adult Connections to Community-driven Early Strengths-based and Stigma-free Services) in November of 2016 and will integrate various community services from the site on King Street in Chatham. Young people and their families can see a trained clinician, peer support workers and/or family support workers who will provide front-line services or connect them to specialized services.

SUBJECT: Reporting Under the Public Sector Salary Disclosure Act for the 2015 Year.

Each year, since the *Public Sector Salary Disclosure Act* was passed in 1996, the Ontario Government has published a compendium on public sector employees who were paid a salary of \$100,000 or more. Organizations that receive public funding from the Province of Ontario are required to disclose the names, positions, salaries and taxable benefits of these employees. The salary required to be made public under the Act reflects the amount to be reported to Canada Revenue Agency on the employer's T-4 slip for the employee. The T-4 amounts may include components that relate to a prior year and may exceed the employee's annual rate of salary. The taxable benefits listed on the report are the amount shown on the T-4 slip as prepared for the Canada Revenue Agency.

The Act covers city and other local governments, universities and colleges, school boards, hospitals, and Crown agencies. It also applies to the Provincial Government ministries and members of the Assembly. Other non-profit organizations that receive a large share of their funding from the provincial government are covered as well.

Attached is the Record of Employees' 2015 Salaries and Benefits for the Lambton Kent District School Board filed in accordance with the Public Sector Salary Disclosure Act.

Re: NBE-C and NBE-U courses

Recently, we were made aware of a course within the Ontario Curriculum called Aboriginal Voices. We understand that this course, NBE 3E/C/U, is a Native Studies course; however, we are also aware that this course can be substituted for the compulsory English course in Grade 11. For this reason, we believe this course provides a great opportunity for our school board to address some of the key recommendations put forth by the Truth and Reconciliation Commission.

This letter is to advise the Lambton-Kent Board of Education of our First Nation's support of the NBE-C and NBE-U courses being offered as an option to grade 11 students, however, the position of the Walpole Island Board of Education is that this course should be made mandatory for all grade 11 students at the Lambton Kent District schools. The benefits outweigh any obstacles at the Lambton Kent District schools.

As you know, the TRC *Calls to Action* point to education as the key element in the process of reconciliation. We believe the students of the LKDSB have a right to and need to learn about the histories and perspectives of First Nations, Métis, and Inuit people. **For this reason, we are writing this letter as an indication of our support for the LKDSB to become active participants in the TRC Calls to Action by making this course, Aboriginal Voices, a compulsory component of the curriculum in all secondary schools.**

FNMI funds are made available to the LKDSB to improve achievement among First Nation, Métis, and Inuit students attending your schools and to close the gap between Aboriginal and non-Aboriginal students in the areas of literacy and numeracy and advancement to postsecondary studies. By implementing these courses as mandatory is demonstrating LKDSB Boards sincerity in moving in the direction of achieving the goals and funding requirements of this funding.

We know that there are many teachers within the LKDSB working hard to include First Nations, Métis, and Inuit histories and perspectives in their classrooms. We also know that there are many students who still don't learn about this part of their history. Regardless of where a student comes from, every student has a right to know our collective history. We would encourage the LKDSB to take this forward-thinking step to implement the Aboriginal Voices

(NBE 3E/C/U) course as the Grade 11 English course for all students regardless of their pathway.

We are very pleased to see the direction that LKDS Board is moving in order to support and build relationships between local communities and surrounding First Nations. Providing students another opportunity to learn about First Nations Peoples will contribute to the healing of relationships, help eliminate racism, stereotype and discrimination. Starting now, we all have an opportunity to show leadership, courage and conviction in helping heal the wounds of the past as we make a path towards a more just and fairer community.

On behalf of the Walpole Island First Nation and our children, I would like to congratulate the Lambton-Kent Board on the positive direction being taken in ensuring the needs of our children are being addressed and met. In the wake of the TRC's calls to action last June, we understand that educators are examining how they can make changes within the core of their institutions, engage more effectively with Indigenous communities and become leaders and partners in building reconciliation. By implementing this mandatory course, our students will have a head start when entering their post-secondary institution of their choice.
