Absence Reporting

When you leave a message, please include your child's first and last name and why they are absent. Our answering machine is available 24 hours a day for reporting absences.

Medical Alerts

Please notify the office immediately if your child has a prevalent medical condition, Asthma, Epilepsy, Anaphylactic to nuts or bees, Diabetes or other.

ALLERGIES – Nuts, Bananas & Perfumes

Many children and staff have severe allergies to peanuts, peanut butter, other nuts, bananas, and sensitivities to smells. In some cases, these allergies can be fatal. We ask for your help as a member of our caring and responsible school. Please do not send your child with any nuts (including nut milk) or peanut butter for either lunches or snacks and avoid scented products. While we realize this may be an inconvenience, we ask that you put yourself in the place of the parents of children with severe allergies. We want our school environment to be safe and healthy for all our students. Some classes may have additional allergies that require your sensitivity, and the classroom teacher will share with the community additional items necessary to avoid at school. I appreciate your understanding.

Consent for Authorization of Medication

If a student must take medication at school, Board policy requires us to have a Medical Physician complete a consent form. Please request the blank form from our school secretary.

School Emergency Procedures

During the year, we will be practicing our emergency procedure drills for fire, tornadoes, as well as procedures for lockdown, hold and secure and shelter in place.

CELL PHONES AND ELECTRONIC DEVICES

It is strongly suggested that all electronic devices stay at home. All electronic devices such as cell phones, digital game devices, and computers, are not to be used while the student is on school property before, during, or after school without the permission of school personnel, and when requested to be used for educational purposes. If a child requires to get in touch with a parent or guardian there are phones at the school available to be used at all hours. If you need to reach your child during the school day, please phone the office and the message will be given to the student.

If a student carries a cell phone, they are responsible for it. Students will not use electronic devices for digital, audio or video recording without permission from the teacher. The school is not responsible for lost, damaged or stolen property. We appreciate your support in limiting distractions at school and assisting in keeping a safe environment for all.

Parking Lot

You will notice that our parking lot has recently had a facelift, providing a safer drop-off and pick-up experience for our students and visitors. When dropping children off in the morning or picking them up at the end of the day, please use the crosswalks that are more visible and do not block the bus lane.

BUS INFORMATION/MySBI - BUS STATUS APP

Getting information about school bus cancellations and delays is easy! CLASS has a mobile app that will provide subscribers with real-time notifications whenever buses are delayed by ten minutes or greater. Buses cancelled due to snow do not pick up students at the end of the day. Buses cancelled due to fog will return to the school to take students home. **MAPS is ZONE 7.**

Only students who are registered with our transportation department may ride the bus to and from school. Bus drivers are responsible for picking students up and dropping them off only at their assigned stop.

Please listen to CFCO AM 630 or CKSY FM 94.3 for information snow or fog days and school closures.

VISTORS-PARENTS-GUARDIANS

In compliance with the Ministry of Education regulations, Merlin Area Public School, along with all other schools in LKDSB, secure all doors and entrances into the school. All doors are locked, including the front door of the school. Students arriving late to school will ring the intercom (front entry) to gain entrance into the school. For the safety of everyone, visitors who have an appointment are welcome to enter the school but must ring the intercom and sign in at the office first.

Parents/Guardians are asked to wait outside the school at the end of the school day. Students will be dismissed by staff from the classrooms. Students who walk home will exit the building using the main front doors of the school at the end of the day.

Dress Code

The school dress code will be consistent with the Human Rights Code and the Charter of Rights and Freedoms (e.g. disability, religious beliefs).

Mennonite Heritage Week

On May 29, 2019, the <u>Government of Canada</u> adopted a motion to officially declare the second week of September as Mennonite Heritage Week. This time is an opportunity to learn more about Mennonite Canadians, their unique history, their vibrant culture, and their contributions that have helped shape our country.

National Day for Truth and Reconciliation- Orange Shirt Day- September 30

The Government of Canada has formally designated September 30, National Day for Truth and Reconciliation, as a federally statutory holiday for employees in the federal government and federally regulated workplaces. This day will be observed to honour First Nations, Inuit and Metis survivors and their families and communities and ensure the public commemoration of their history and the legacy of residential schools.

The Lambton Kent District School Board will commemorate the impact of residential schools on **Friday**, **September 29**, **2023** – **Orange Shirt Day**. Students and staff are encouraged to wear orange shirts and use this day as a catalyst to encourage learning and understanding about the residential school system and the impacts that system has had on First Nations, Metis, and Inuit people. This is a meaningful way as school communities to come together in a spirit of reconciliation and hope because "Every Child Matters". Respectfully, flags at all LKDSB schools and facilities will be lowered on this day.



This recognition day will be part of the activities and discussions occurring during the Truth and Reconciliation Week, which will also include discussions about the truth of Indigenous treaties, languages and culture and First Nation, Metis, and Inuit land claims.

Fair Notice Communication Regarding Violence Threat Risk Assessment Protcol

The Lambton Kent District School Board is committed to providing safe learning environments for all students, staff, school visitors, and community members. When a student behaves inappropriately, principals will most often employ progressive discipline strategies to help a student take responsibility for their actions, learn from their mistakes, and make better choices in the future.

In more extreme cases however, when a student's behavior poses a potential threat to their own or others' well-being, the Community Violence Threat Risk Assessment Protocol (VTRA) supports principals in taking further steps to safeguard everyone.

The VTRA protocol outlines how a school responds immediately to threatening incidents including but not limited to: possession of a weapon or replica weapon, bomb threat or plan, verbal or written (including electronic) threats to harm oneself or others, other threats of violence, and fire setting.

The initial response team is likely to include the Principal, police, and board staff. Should conditions warrant, a Community Threat Assessment Team will be convened. This community team includes representatives of community agencies who work with schools and boards to keep our students and staff safe, such as local police and children's mental health organizations.

Parents and guardians will be notified if their child will be discussed through the Community Violence Threat Risk Assessment Protocol. If parents/guardians cannot be reached, or if they choose not to provide consent, but a concern for safety still exists due to threatening behavior, the threat assessment may still proceed. Personal information shared throughout this process will respect and balance each individual's right to privacy with the need to ensure the safety of all.

As always, student safety is our priority. This notification is being provided via avenues such as school newsletters, and school and board web sites as fair notice to parents and guardians of the existence of the VTRA Protocol and its application if situations warrant.
