Ad Hoc Naming Committee for the Kindergarten to Grade 12 School in Forest Report B-18-124	Chair Hudie explained that in March 2017, Trustees passed a motion to form an Ad Hoc Naming Committee for the consolidated Kindergarten to Grade 12 School in Forest in the event that the Ministry approved the grant application. She confirmed that in January 2018, the Ministry notified the LKDSB that the funding for the school had been approved. She advised that Trustees Bryce and Fletcher have agreed to serve on the Ad Hoc Naming Committee. Superintendent Girardi is working with Principals of the schools involved to collect the names of School Council Chairs, students, staff and community representatives to serve on the Ad Hoc Committee. The Ad Hoc Naming Committee will meet to establish criteria for the new consolidated school name, the process to gather input from appropriate stakeholders and timelines for community input. He advised that in accordance with the LKDSB Procedural By-laws and the Education Act, the Director presides over the meeting until a Chair of the Board is elected. The official returns of the election of the Trustees for the Board have been received from the various Municipal Clerks as well as letters from the First Nation partners. The Declarations of the Office and the Oaths of Allegiance pursuant to the provisions of the Education Act have been completed and filed. Director Costello congratulated everyone on being elected to the position of Trustee to govern the LKDSB. He shared that the Board has approximately 22,000 students in 62 schools with over 3,000 staff. He referred Trustees to the Board's Vision, Mission and Belief Statements and the Engagement Model displayed on the wall in the Board Room. He explained that the documents guide the decision making efforts of the Board. The Board seeks to engage with all stakeholders - students, staff and parents/guardians and community. He commented that the LKDSB is a progressive school board; one where staff are pushing the envelope of innovation to improve the learning conditions in classrooms with a strong marriage of technology and sound pedagogy. Staff are hardworking and with a strong focus on improving outcomes for all students. He noted that just as staff and administration focus on all students, Trustees focus on the best interest of all students as well. He noted that Trustees and Administration work together to make decisions with the best interests of all students in mind. On behalf of the Senior Executive Team, he welcomed a new LKDSB organization and advised that Administration was looking forward to working with the Trustees as work begins on the develop a new Strategic Plan which will provide stable direction for the Board.

SUBJECT: Indigenous Liaison Committee Report

The November 26, 2018 meeting of the Indigenous Liaison Committee (ILC) was held at the Bkejwanong Kinomaagewgamig (Walpole Island School) Library with Trustee Lareina Rising chairing.

The Record of Action from the September 27, 2018 and October 23, 2018 meetings were reviewed and approved at the November 26, 2018 meeting.

Reports from the First Nation Communities were received:

Kettle and Stony Point First Nation: Zandra Bear-Lowen explained they were researching the use of Apple apps and the required professional development that teachers need with Apple products. Going forward there will be an increased focus on math to improve mathematic skill. She also shared that students and staff recognized Treaty Recognition Week and Remembrance Day with various activities.

Walpole Island First Nation: Everett Kicknosway noted that the Bkejwanong Children's Centre, the first children's center of its type, celebrated its 50th Year Anniversary. He also explained that they have a shortfall of staff at the Harriet Jacobs Center located at Wallaceburg District Secondary School. Chief and Council would be meeting to discuss the Memorandum of Understanding and the Education Service Agreement at their next meeting.

Aamjiwnaang First Nation: Vicki Ware discussed the work that is being done on creating their strategic education plan expectations. They are close to completing the framework for the early years Language app that they are developing which is based on the thirteen moons. The app is built on conversational sentences not just singular words and it will also include games and activities. She also noted that all schools were involved in Orange Shirt Day and Treaty Week.

Trustee Lareina Rising announced that she will continue in her role as the First Nation Trustee for the next four years. She was congratulated by the Committee for her second term appointment.

Indigenous Lead, Minogiizhgad, introduced the LKDSB's Indigenous Education and Special Projects Elementary Teacher, Gretchen Sands-Gamble who presented a video and survey responses on Orange Shirt Day. Her role is to support elementary teachers by hosting workshops, providing resources, updating a department blog, and supporting staff to organize presenters and opportunities to hear student voice. A lengthy discussion occurred about the importance of Orange Shirt Day as a commemorative day and all the work that is being done to increase awareness and knowledge about the importance of the day. Minogiizhgad acknowledged how the growth is evident by the increased requests for information and presenters. He also discussed some ideas for the Youth Symposiums which will be held during the Spring of 2019 and acknowledged how technology could be used to promote language. Minogiizhgad will provide Committee members with more detailed information as requested.

Indigenous Liaison Committee Report

Superintendent Helen Lane provided additional information about the process of registration fees for students and how it is determined between the Ministry of Education and the school boards with property tax levies. She acknowledged that the Board Action Plan (BAP) 2018-2019 was signed and submitted to the Ministry of Education. She also indicated that a formal invitation was sent to First Nation communities for the selection of a Special Education Advisory Committee (SEAC) representative and alternate.

Administrators from Ridgetown District High School, Sir John Moore Community School, A. A. Wright Public School, John McGregor Secondary School, H. W. Burgess Public School and Wallaceburg District Secondary School attended the meeting along with System Coordinators for Multi-Discipline Team and Alternative and Continuing Education. Trustee Rising encouraged administrators to send their written reports so that they could be forwarded to community members.

The next ILC meeting is scheduled on January 17, 2019 at 6:00 p.m. at Aamjiwnaang First Nation's Maawn Doosh Gumig Community & Youth Centre.

SUBJECT: SPECIAL EDUCATION ADVISORY COMMITTEE (SEAC) MEETING SUMMARY

The Special Education Advisory Committee of the Lambton Kent District School Board met on December 13, 2018 at Wallaceburg District Secondary School.

Presentation – Supports in Response to Violence in the Classroom

Tracy Ronsick, Itinerant Resource Teacher High Needs Team, and Deborah Stewardson, Itinerant Student Support Teacher, explained that behaviour occurs for one of four reasons: to escape a task or social setting; to seek attention (negative or positive); obtain something tangible such as materials, activities or food; or, for sensory stimulus.

The High Needs Team members make observations and/or collect data to look for antecedents to the unwanted behaviour so that changes can be implemented. The Team works with school staff to correct the environment that surrounds the student to help them cope. In areas where the school has no control over the student (i.e. a lack of sleep, lack of food/medication, problems at home, etc.) staff look for proactive strategies that can be put into place to offset the problem(s) the student is facing.

Behaviour Management Systems (BMS) training is used to keep both staff and students safe at school. The BMS has four phases: planning; information-gathering; action; and a review/debrief. BMS training allows staff to know what their responses should be to help them remain calm when responding to situations that arise.

Correspondence

Letter from the Windsor-Essex Catholic District School Board Regarding Special Education Funding A letter outlining funding concerns was received. The Committee requested that a letter of support be drafted by administration and placed on the January Meeting Agenda for discussion/approval.

Letter from Brant Haldimand Norfolk

A letter citing, concerns about the increase in students with potential fetal alcohol spectrum disorder (FASD) and the lack of the adequate supports for these students, was received by the Committee. A presentation on FASD will be made at the February SEAC Meeting. If the Committee wishes to support Brant Haldimand Norfolk's request (that FASD be added to the Education Act as an exceptionality), they will request that a letter of support be drafted at that time.

Association Reports

For the benefit of the new Trustees, each agency's representative provided an overview of the programs and services their organization currently offers.

The new LKDSB Trustees appointed to SEAC indicated they were very happy to have been appointed to the Committee.
