# ADMINISTRATIVE PROCEDURES 

## SUBJECT: Secondary Course Codes

Secondary school courses must comply with the official Ministry title and course code. Each of the curriculum policy documents identifies the title and course codes. For the most current course codes, refer to the Ministry of Education website (http://www.edu.gov.on.ca/eng/curriculum/secondary/).
If there are discrepancies, the curriculum policy documents contain the official codes/titles.
All course codes consist of six characters. The first three characters are those given in the ministry's list of common course codes. The fourth character indicates the grade of a course, as follows:

1 (Grade 9) 2 (Grade 10) 3 (Grade 11) 4 (Grade 12)

For courses in ESL, classical/international languages, and Native language only, the $4^{\text {th }}$ character indicates the level of a course, as follows:
A (level 1)
B (level 2)
C (level 3)
D (level 4)
E (level 5)

The fifth character indicates the type of course, as follows:

| C (College Preparation) | D (Academic) |

| E (Workplace Preparation) | H (Transfer) |
| L (Locally Developed) | M (University/College Preparation) |
| O (Open) | P (Applied) |
| U (University Preparation) |  |

## Sixth Character

The Ministry allows the sixth character to be determined by each Board. This character is used for tracking courses, identifying the credit value, and/or identifying unique features of a code. The sixth character can be either a number or a letter. The following is a list for our Board, effective June 2019.

## Numbers

1 - one credit course
2 - two credit course
5 - half credit course (Civics and Career Studies, grade 10)
