# YOUR EXCEPTIONAL CHILD, SCHOOL, AND SPECIAL EDUCATION SUPPORTS

This brochure is intended to help prepare you and your child for school where special needs are a consideration. Every child is entitled to be provided with an opportunity to develop to their full potential educationally. A partnership between the student, their family, the school, and community support services is essential to the success of all students. You are your child's advocate. The following information and potential resources will help you in this important role.

#### **Children with Special Needs**

A child with special needs is "a pupil whose behavioural, communication, intellectual, physical or multiple exceptionalities are such that the pupil is considered to need placement in a special education program".

#### Rights outlined in the Education Act and in its Regulations:

The <u>Education Act</u> and its Regulations sets out that all school-aged children are entitled to a publicly-supported education. Pupils with special needs have a right to special education programs and services.

#### Who Are Your Partners?

- Local School: Your primary contact is the School Principal who can initiate the process that will lead to identifying your child's special needs and the most appropriate special education supports for your child.
- Lambton Kent District School Board: The Public School Board serving Chatham-Kent and Sarnia-Lambton is comprised of a Board of Trustees, Education Centres in Sarnia and Chatham, and staff located at schools throughout the area.
- Special Education Advisory Committee (SEAC): SEAC is a Boardappointed committee representing provincial groups and the public, who advise the Board regarding special education programs. These provincial groups are excellent contacts as they represent some of the exceptionalities listed on the next page.
- Ontario Ministry of Education: Sets the standards for District School Boards including the requirements for Special Education Plans and provides funding to the Board for this Plan.

## What Are Your Responsibilities as Parent/Guardian?

You are your child's best advocate. As an advocate you can:

- Participate with the school identification and planning process.
- Familiarize yourself with Board policies and procedures.
- Become acquainted with school staff involved with your child.
- Inform yourself through the other available resources.
- Support your child at home.

## **Contacting the School:**

Although you can contact your local Principal at any time, typically, contact will be made at the following times:

- For New Students Registering for Junior or Senior Kindergarten: There is an Early Identification Process to identify each child's learning needs and identify the required supports.
- For Existing Students: Talk to your child's teacher. There is a school team that can meet with you to develop strategies and explore alternative plans. You can also request an IPRC to initiate a review and placement process for your child.
- For School-Aged Children New to the Board or School: Talk to your local Principal.
